# Passenger Contract - Turkey

## General Terms and Conditions

**Operator Agreement** This agreement sets forth the terms and conditions pursuant to which WGBH and Distant Horizons (hereinafter referred to as "Operator"), 350 Elm Avenue, Long Beach, CA 90802 in return for payment by the passenger of the amount specified as the trip price, agrees to provide the services and features as described in the tour brochure. Please read this agreement carefully before sending any money.

**Tour Cost** The price of the Turkey: Ancient Land and Modern Nation tour is \$6,190 per person, including economy round trip airfare from Boston-Turkey, exclusive of air taxes and surcharges. This price is based on double occupancy and a minimum of 20 persons. Air taxes and surcharges will be billed separately at time of booking. Ground-only price is \$5,240. Tour price also includes a \$600 contribution to WGBH. Single supplement for the tour is \$1,270. See note under "Accommodations" below.

**Reservations and Method of Payment** The deposit for the tour is \$1,000 per person. Payment is accepted by check or money order made out to WGBH, or credit card (Visa, MasterCard, or AMEX). The deposit must be received at WGBH by Tuesday, July 15, 2008. \$500 of the deposit is non-refundable.

Please complete the tour reservation form to accompany your payment and mail to: WGBH LearningTours - Turkey, One Guest Street, Boston, MA 02135. Upon receipt of deposit, WGBH will send a letter of confirmation and travel insurance information. Prior to departure, additional items of interest will be mailed to the participants. If you have any questions, please contact WGBH at 617-300-3505. A pre-departure information session will be arranged and hosted by WGBH for all participants. Please note that tour participation is limited to 25 participants or as space allows.

**Final Payment** The balance is due to WGBH by Friday, August 15, 2008.

**Rates** Prices quoted are based on fares in effect at the time of printing and are subject to change prior to departure. Prices could increase in the event of severe currency fluctuations. Specifically, if the Euro exceeds \$1.58 there will be an adjustment in the price of the tour. Participants will be notified of any such price increase at least 30 days prior to departure. Please note that air taxes and surcharges will be billed separately at time of booking.

**Cancellations** You are entitled to a full refund if the tour is cancelled by WGBH or Distant Horizons. If you should cancel, there is a non-refundable \$500 fee. The remaining balance (minus the \$500 fee) will be refunded according to the following schedule:

On or Before July 15, 2008:	100%
On or Before August 16, 2008:	50%
On or Before September 1, 2008:	25%
After September 15, 2008:	0%

Notice of withdrawal from the tour must be communicated to Mary Toropov by email to [mary\\_toropov@wgbh.org](mailto:mary_toropov@wgbh.org) or by fax to 617-300-1026. All cancellations will be confirmed by Mary Toropov at WGBH.

Ticketed passengers must return unused tickets and any other negotiable vouchers for an applicable refund to be processed. No refund will be given for any passenger who, for any reason, does not arrive for either airline or vehicle departure. No refund will be made for features the passenger opts not to use. Once travel begins, any change made by a passenger is the responsibility of the passenger. Cancellation penalties caused by accident or illness to a passenger does not constitute waiver of applicable fees. Refunds will be processed within 90 days of receipt of cancellation notice.

**Itinerary or Program Modifications** While every effort will be made to adhere to the tour itinerary as planned, WGBH and Operator reserve the right to modify the itinerary or programs at their discretion, as warranted by circumstances at the time of the tour, including cancellation of performances, performance or cast changes, or similar events beyond their control. In the event of any changes, WGBH and Operator will work to substitute programs of comparable quality.

**Transportation** Participants are responsible for booking alternative air travel. Participants arriving or departing on other dates or from other destinations will be responsible for meeting up with the group in Ankara and for any fees incurred by these arrangements.

**Travel Insurance** Because cancellation policies are strictly enforced, we strongly recommend for your protection that you purchase trip cancellation insurance. Travel insurance also is highly recommended in order to protect participants who must cancel or interrupt their trip due to illness or injury. Trip cancellation insurance information is available from WGBH. Information will be sent after your reservation is received.

**Responsibility Disclaimer** WGBH is not the tour operator. WGBH acts only as agent for the participants with respect to travel services, and shall not be responsible for fare changes, dishonor of hotel or other reservations, delays, injuries, inconveniences, cessation of operations, airline or tour operator bankruptcies, loss of baggage, accidents, or for the acts or defaults of any person or entity engaged in conveying participants or in carrying out other arrangements of the tour.

Further, WGBH and Operator shall not be responsible for losses or additional expenses of the participant due to sickness, weather, strife, civil unrest, acts of terrorism, quarantine, acts of God, or other causes beyond their control. The right is further reserved to decline to accept or to retain any person as a member of the tour should the person's health, actions, or general department impede the operation of the tour or the rights or welfare of the other participants. No refund will be made for any unused portion of the tour.

*Please note that there is a moderate amount of walking on this tour.*

**Limitations** Operator reserves the right to decline or reject any passenger for the tour at any time. The air carrier, other service providers and Operator reserve the right to substitute aircraft, vehicles and accommodations without penalty.

**Force Majeur** In the case of any event not caused by the fault of the Operator preventing the safe performance of this tour occurring before the embarkation of the passengers, the Operator is entitled (giving as much notice as possible to the charterers) to cancel or terminate the tour, reimbursing the passengers with any sums already paid hereunder. In the case of such an event preventing the safe performance or continuance of the tour occurring after the embarkation of the passengers, the Operator is entitled to terminate the tour, without further liability on their part.

**Law Applicable** The agreement between Operator and passengers is governed by the laws of the Commonwealth of Massachusetts.
